The Virginia Western Community College Board held its October 12, 1970 meeting in the President's Conference Room at 11:00 A.M. prior to the legislative luncheon to be held at noon. Members present were:

SIDEWALK ALTERATIONS, FOOT OF NORTH CAMPUS:

Mr. Harry Bradley explained, with photographs that were passed around, the need for alterations on the sidewalk at the foot of the North campus. The curb should be lowered about six inches. The estimated cost is about \$600. A motion made by Mr. Hahn to appropriate \$600 for the sidewalk alterations on the North campus was seconded by Mr. Morris and passed.

GUEST:

Mr. Russell introduced Mrs. Pat Perkinson, Administrative Assistant to Dr. Hamel. Mrs. Perkinson will attend the legislative luncheon to be held today.

PARKING ORDINANCE:

Dr. Hopper read a letter from Julian Hirst telling us that they are still attempting to work out a parking ordinance for Virginia Western. Dr. Hopper plans to be present at the City Council meeting when this is placed on their agenda.

PARKING LOT:

With a 35% increase in enrollment, we need more parking spaces. We have a limited amount of money allocated for parking which will not be enough to cover our present parking needs. Mr. Vinyard moved that the Executive Committee study the need for another parking lot and make any decisions relative to preparations so that final paving can be accomplished around July 1971. Motion seconded by Mr. Thomson and passed.

Mr. Thomas, Mr. Thomson, and Mr. Vinyard are the present Executive Committee members of the board, along with Mr. Russell and Dr. Hopper. A meeting of the Executive Committee and Roy Kinsey will be arranged.

INSURANCE MANAGEMENT CURRICULUM:

Final decision on this curriculum was tabled until the December meeting.

SGA BUDGET--CHRISTMAS DANCE:

Mr. Harry C. Race, Dean of Student Services, asked the board's support for the operation of the Christmas dinner dance. The cost for each ticket was estimated at \$4.00 a person and will be held at Dixie Caverns. A questionnaire was given out to a fair percentage of students and two out of three said they would be willing to pay \$4.00 a ticket. Mr. Vinyard moved that the board support this budget should the SGA be unable to cover its commitments. Motion seconded by Mr. Thomson and passed. Mr. Hahn suggested that each ticket be \$5.00 a couple, with the Student Activity Fund subsidizing the balance of \$3.00 a couple.

FILMS:

Mr. Hahn moved that \$300 be appropriated for the rental of entertainment films to be shown to the students during the free period on Monday, Wednesday or Friday. Motion seconded by Mr. Thomson and passed.

LOCAL BUDGET PROGRESS REPORT:

Dr. Hopper reported we have received partial payments from all of our local political subdivisions and in some cases full payment.
