# Are you prepared for future campus closures?

As things with the COVID 19 pandemic continue to evolve, we are thinking about how to be prepared for the possibility of another campus closure. We have created a quick and simple technology survey that you can use in your classes to find out what type of technology students have access to at home. You can do this ahead of a closure to be ready or in the early days to help gauge what instructional technologies and strategies you may need if we are required to return to Emergency Remote Instruction. This survey can be imported from Campus Commons directly into your Canvas course shell and modified to meet your specific needs.

#### Classroom Video:

If you use video in your courses there is new information that you need to be aware of.

**Classroom Recording and FERPA** – New guidance from the US Department of Education limits the use of classroom recordings containing personally identifiable information of any student. We have created a web page with more information and resources that will help us to meet these new guidelines..

**Accessibility and Video** – We are strongly encouraging faculty to begin using the automated captioning feature on all new video recordings that are created for use in a course. Panopto, Zoom, and Canvas Studio all have automated captioning features builtin that are accurate in the 85-90% range. Faculty simply need to turn on this feature when making any new recordings. We have provided instructions on how to turn on automated captioning in all of our VWCC video platforms including YouTube.

# **RSI - Regular and Substantive Interaction**

The U.S. Department of Education requires that all online courses for which students may use Title IV funds (federal financial aid) "ensure that there is regular and substantive interaction between students and instructors." The July 2020 regulations implemented by the Department of Education outline the requirements of accrediting agencies for evaluating online courses.

These regulations, are complex; the resources linked below are meant to provide clarity and guidance to faculty on to the design and delivery of online courses that will meet the

new RSI standards.
