

If you are interested in applying to Medical Lab Technology program at VWCC/Joint Venture with Mountain Gateway CC, you <u>must</u> complete the **VWCC** college application, as well as the program application form (other required material is discussed on the "Apply Now" page). The college application must be submitted on-line. This is also required for those interested in the Joint Venture site at Mountain Gateway Community College. All applicants are encouraged to complete now, but no later than the deadline.

Those applying for the MGCC site will also need to complete a college application for MGCC before July 1 (unless you are already registered as a student there or plan to complete courses at MGCC prior to summer 2025). At Mountain Gateway, please select the plan of Advanced Health Care Certificate.

The program application must be mailed, emailed via pdf attachment, or brought to Health Professions Advising and Applications Office in the Fralin Center for Science and Health Professions,-Room 339 at VWCC (all material required by **July 1**st). All application materials must be sent <u>addressed directly</u> to Pam Woody at VWCC in Roanoke. The HP Advising Team can provide advising assistance <u>after</u> reviewing your official transcripts. In addition, you can address application concerns, advising questions and etc. by contacting a team of advisors at <u>healthprofessions@virginiawestern.edu</u>. Applicants for the Joint Venture at MGCC <u>do not</u> need to submit transcripts to MGCC to apply to this program. <u>All</u> Application materials are submitted to Pam Woody at VWCC.

You are encouraged to complete the VWCC college application on-line by logging into the system at <u>https://apply.vccs.edu</u>



Indicate Virginia Western Community College as the college you plan to attend and your plan of study as **Career Studies Certificate: Introduction to Medical Laboratory Technology**. Also apply to **Mountain Gateway CC and choose Advanced Healthcare Certificate as your plan of study**. At VWCC, choose the earliest semester or term you may be likely to register for any class at VWCC or no later than summer 2025. High school seniors should select the fall semester (2025). If, upon completion of HS, you wish to take a summer course and encounter problems registering, you should seek assistance from the college enrollment center in Chapman Hall. If any applicant encounters difficulty submitting your information electronically, further assistance may be available in Chapman Hall for students.
