Section 1: Purpose

The purpose of this articulation agreement is to create a seamless transition from Virginia Western Community College (VWCC) to the University of Alaska Southeast (UAS) for students in pursuit of a Bachelors in Business Administration (BBA). Students from VWCC, through this articulation agreement, will be allowed to transfer credits earned for the A.S. in Business Administration (A.S. BA) to the award of the BBA, as specified in the attached curriculum articulation table. The following general principles guide the operation of this Agreement:

1. The program is designed for graduates of the A.S. BA at VWCC.
2. A maximum of 60 credits from VWCC will be allowed toward the fulfillment of the 120 credit hours required for the BBA.
3. The standard that requires 42 credits of upper-division (300 or above) courses, 24 of which must be completed at UAS, will apply to students transferring to UAS under this Agreement. Transfer courses retain the course level of upper or lower division credit established at the original college or university, [per the UAS catalog](#).
4. Starting in the Fall of 2024, any VWCC student transferring to UAS holding an A.S. BA, will be considered to have completed UAS GERs, however, they may require additional UAS general education requirements (GERs) to be completed as part of the BBA degree, [per the UAS catalog](#), in addition to the three-credit Alaska Native Knowledge. Graduation Requirement (ANKGR).
5. Students must maintain a 2.0 (C) cumulative grade point average in order to transfer.
6. Once the A.S. BA degree is completed at VWCC, and the student has been admitted to UAS, the student may commence the BBA.
7. VWCC students who have completed the A.S. BA will be given every consideration for financial assistance and will be eligible to compete for academic scholarships at UAS.
8. Credits will be applied toward the UAS BBA degree requirements according to Table 1. In cases where a student is missing a course listed on the table, the course may be taken at UAS.

Admission will be given to applicants submitting all of the following requirements by the priority deadline:

1. UAS Transfer Application submitted by the application deadline along with the application fee.
2. Meet all other requirements for admission.

Section 3: Joint Obligations

VWCC and UAS agree to:

1. Provide links on their institutional web sites indicating the existence of this agreement.
2. Exchange data and documents that will contribute to the maintenance and improvement of this articulation agreement and promote effective cooperation between the two institutions.
3. Undertake an annual evaluation of the partnership supported by this articulation agreement and use the findings to improve the transfer process for students.


Section 4: Duration of Agreement

This agreement is valid when signed by authorized representatives for VWCC and UAS. This articulation agreement will be reviewed every four years. If either party chooses to discontinue the agreement, the parties will honor the agreement for any student who satisfies both of the following conditions:


1. The student has started on the A.S.-BA at VWCCC prior to the notice of discontinuation of the agreement.
2. The student is on schedule to, and does, graduate from VWCC in two years or less.

Each party to this agreement shall be responsible for any and all claims, damages or other liability, including costs of defense and attorney's fees, arising out of the acts or omissions of its officers, employees and/or agents in the performance of its obligations under this contract. Neither party assumes responsibility for the consequences of any act or omission of any person, firm or corporation not a party to this agreement.


